#### Florin Bîlbîie, PhD

University of Cambridge, Faculty of Economics

Florin Bîlbîie is Professor of Macroeconomics, Senior J.M. Keynes Fellow, Janeway Institute Coordinator, University of Cambridge. His outstanding research provides him with the opportunity to be Research Fellow of the CEPR (Centre for Economic Policy Research), London, UK, Regular Research Visitor of the Research Department within European Central Bank, Frankfurt, and Research Fellow of the Nuffield College. He is Editor of Quarterly Journal of Economics and European Economic Review.

Florin's research focusses on aggregate demand under heterogeneity and inequality, aggregate supply with entry and variety, business cycles and monetary, and fiscal stabilisation policies.



#### Daniela Andrén, PhD Örebro University School of Business

Daniela Andrén is Associate Professor of Economics at the School of Business of Örebro University. Additionally, she held researcher positions at the University of Gothenburg, Department of Economics with Statistics, and Department of Social Work. She is member of the Editorial Board of Scandinavian Journal of Public Administration and referee for important journals and books

Her main research interests are labour and health economics, with a focus on the evaluation of public policies. In addition to her research activities, she actively participates in educational projects aimed at developing and implementing teaching methods to enhance students' learning outcomes and overall well-being.



# We are pleased to announce the XXI International Conference on Finance and Banking FI BA 2024.

The aim of the Conference is to exchange ideas of the state of the art for new research results, perspectives on upcoming progress and novel applications relevant for banking and finance markets.

#### **Regular Parallel Sessions**

Regular parallel sessions will be organised with the presentation of referred papers followed by a discussion session. The discussant assignments will be made by the Conference organizers, which will send the paper to the discussant. Researchers are invited to submit empirical and theoretical papers that are broadly consistent with the special topics of the Conference, but not limited to them: banking, financial markets and institutions, derivatives and risk management, investments, behavioural finance, corporate finance, insurance, operational research in finance, public finance and macroeconomic stability, monetary policy and financial stability, quantitative finance and financial mathematics.

#### **INFER Special Session**

During the FIBA 2024 Conference, we organize an INFER special session which is open to contributions from all areas of economics. We welcome both empirical and theoretical papers related to the following non-exhaustive list of topics: banking and finance, bounded rationality in economics and finance, commodities and financial markets, economic asymmetries, energy economics and policy, environmental economics, empirical economics, experimental economics, financial advancements and economic integration, financial flows and geopolitical risks, firms green transition, fiscal policy and public finance, housing economics, monetary policy and financial markets uncertainty, public policy and economic inequality, sustainable development.



**Best Ph.D. paper award** (500 Euros) will be assigned in line with the tradition of the International Conference on Finance and Banking FI BA 2024. The awarding ceremony will take place during the event. Candidate(s) for the Best Ph.D. paper award must be registered for the FI BA 2024 Conference at the time of submission of the paper. He/she (or they) cannot hold a Ph.D. at the time of submission of the paper. Papers for the Best Ph.D. paper award can only be authored by Ph.D. students.

The Conference language is English.

Paper Submission Deadline: May 5, 2024

Notification of paper acceptance/rejection: May 12, 2024 by e-mail to the corresponding author.

Deadline for payment of fees for accepted papers: May 16, 2024

#### **Submission of papers**

The submitted papers must not have been previously published or currently submitted for publication elsewhere. Only full papers must be submitted in PDF (one PDF where the author/s of the paper must be indicated and another PDF without the author/s of the paper) by May 5, 2024.

Papers for the regular **parallel sessions** will be submitted to <u>fiba@fin.ase.ro</u>. Submissions to the regular parallel sessions are limited to two papers per participant.

Papers for the **INFER special session** must be submitted to the session organizer, Professor Andreea STOIAN, Ph.D. (<u>andreea.stoian@fin.ase.ro</u>). Authors are allowed to submit only one paper for this special session.

All submitted papers will be peer reviewed according to a fast and high-quality referee process. Authors will be notified whether their paper is accepted for presentation no later than May 12, 2024. Papers accepted for the Conference will be discussed, and we expect participants to act as a discussant for the paper assigned.



#### **Publication opportunity**

The organizing committee provides conference participants with the following publication opportunities: Eastern European Economies and Review of Finance and Banking.

The authors accepted at the INFER special session are also invited to submit their papers to special issues in: Journal of Applied Economics and Eastern European Economics.

The conference participants are eligible to submit to the above journals the conference participants' revised paper based on discussant and recommendations. The papers will follow the editorial process of the journals.

#### Registration

The authors are invited to register for the XXI International Conference on Finance and Banking FI BA 2024 after receiving the acceptance of the paper. The deadline for fee payment is May 16, 2024.

#### **Conference fee**

The Conference fee is **EUR 100** (or equivalent in lei at NBR exchange rate) for each paper and covers Conference registration and materials, access to all Conference sessions, snacks & coffee breaks, lunch, gala dinner (on May 30, 2024).

A discount Conference fee of EUR 50 is available for Ph.D. students and is applicable only if all the authors are Ph.D. students.
