Deadline for fee payment for accepted papers: February 20, 2013 (<http://www.fin.ase.ro/FIBA2013/payment.asp>).

Submit the receipt confirming the payment of the fee until February 23, 2013 (<http://www.fin.ase.ro/FIBA2013/payment.asp>).

Paper presenters are expected to discuss one other paper during the conference. The discussant assignments will be made by the conference organizers to **February 25, 2013**.

Submission deadline for final papers for journals: April 30, 2013 (online http://www.fin.ase.ro/FIBA2013/paper_submission.asp).



Papers will be evaluated for originality, significance, clarity, and contribution. Submitted papers must not have been previously published or currently submitted for publication elsewhere. At the conference will be accepted maximum two papers for each participant.

When submitting the papers, they will be accompanied by the registration form filled in entirely. Papers should be send as .doc or .docx files. All the papers should be in the English language. Papers should respect the template of selected journal (see below). If the author chose not to publish, he/she could use a free template.

All submitted papers will be accepted to the conference based on a blind review process. During the conference the author will benefit by the recommendations of a discussant.

If authors chose to publish the paper, the final version of the papers should be send back, with the required changes according to the discussant's feed-back during the conference, until **April 30, 2013**. Further information about the publishing stage will be offered by the board of selected journals.

Publication Opportunity

Publication opportunity in four refereed journals: *Review of Finance and Banking*, *Theoretical and Applied Economics*, *Romanian Journal of Fiscal Policy* or *Budgetary Research Review* subject to compliance to review report, editorial comments, conference feedback and payment of applicable publication fees.

Conference fee

The conference fee is EUR 100 (or equivalent in lei at NBR exchange rate) for each paper. Discounted conference fee of EUR 70 is available for PhD students and it is applicable only if all the authors are PhD students.

The conference fee must be paid until **February 20, 2013** by means of bank transfer to the bank account indicated on the conference website. After that date, participation to the conference is possible at a walk-in participation fee of EUR 150 (EUR 100 for PhD students), payable in cash during conference registration or by bank transfer beforehand.

The authors are invited to submit until **February 23, 2013** the receipt confirming the payment of the fee.

The fee payment will be confirmed until **February 25, 2013** by the Organizing Committee of the conference after submitting the copy of the payment document.

The fee covers registration, program, and access to all conference sessions, coffee breaks, lunch and festive dinner. The conference package will be available only for the authors who attend the event and present their paper. Participants are responsible for their travel and accommodation arrangements. The conference fee does not cover travel and accommodation costs.
