Submission deadline for the revised papers that will be considered for publication according to the authors' preferences and editorial process of the conference journals: April 30, 2015. Detailed information will be send to each participant by e-mail.

Papers will be evaluated for originality, significance, clarity, and contribution. Submitted papers must not have been previously published or currently submitted for publication elsewhere. At the conference will be accepted maximum two papers for each participant.

When submitting the papers, they will be accompanied by the registration form filled in entirely. Papers should be send as .doc files (Word 97-2003 Document). All the papers must be written in English. Papers should respect the template of selected journal according to the first option selected by the authors (see below). If the author chose not to publish, he/she could use a free template.

All submitted papers will be accepted to the conference based on a blind review process. During the conference the author will benefit by the recommendations of a discussant.

If authors chose to publish the paper, the final version of the papers must be send by e-mail (fiba@fin.ase.ro), with the required changes according to the discussant's feed-back during the conference, until April 30, 2015. Papers will be reviewed for the above journals following their normal review criteria. Further information about the publishing process will be offered by the conference organizers and board of selected journals.

#### Conference fee

The conference fee is EUR 100 (or equivalent in lei at NBR exchange rate) for each paper. Discounted conference fee of EUR 70 is available for PhD students and it is applicable only if all the authors are PhD students.

The conference fee must be paid until February 20, 2015 by means of bank transfer to the bank account indicated on the conference website.
