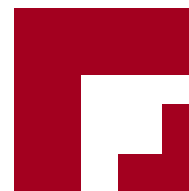

### Call for Papers INFER Special Session

The **INFER Special Session** provides a great opportunity for members and non-members of INFER alike to exchange ideas and to discuss results from recent economic research. Therefore, the aim of this special session during the FI BA 2025 conference is to bring together scholars, researchers, policy makers who share the same interests in finding answers and providing solutions to current challenges.

The special session is open to contributions from all areas of economics. We welcome both empirical and theoretical papers related to the following non-exhaustive list of topics: *applied econometrics (micro and macro), computational economics, development economics, economic integration, emerging market economies and globalization, empirical economics, energy economics, environmental economics, experimental economics, growth and business cycle, fiscal policy and public debt, health economics, housing and real state economics, industrial economics and innovation, international trade and FDI, international macroeconomics, labor economics, monetary economics, urban and regional economics.*

#### INFER Special Session Paper Submission Procedure

Full papers must be submitted to the INFER special session organizer, **Prof. Andreea STOIAN, Ph.D.** ([andreea.stoian@fin.ase.ro](mailto:andreea.stoian@fin.ase.ro)) by **May 12, 2025**. Authors are allowed to submit only one paper to this special session. All submitted papers will be peer-reviewed according to a high-quality and fast referee process. Authors will be notified whether their paper is accepted for presentation at the special session no later than **May 19, 2025**. Special session presenters are expected to discuss the papers during the session. The conference organizers will make the assignment of discussants at a later date.

Papers must be in English and include a cover page with the following information:

- An abstract of up to 500 words, with JEL classification and no more than 5 keywords
- Authors' full name and affiliation
- Contact details for the corresponding author (e-mail)
